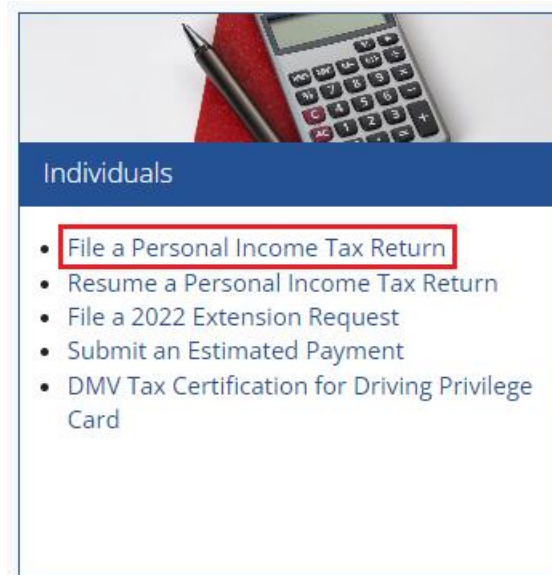


Delaware Taxpayer Portal – Filing a Personal Income Tax Return Without a Portal Account

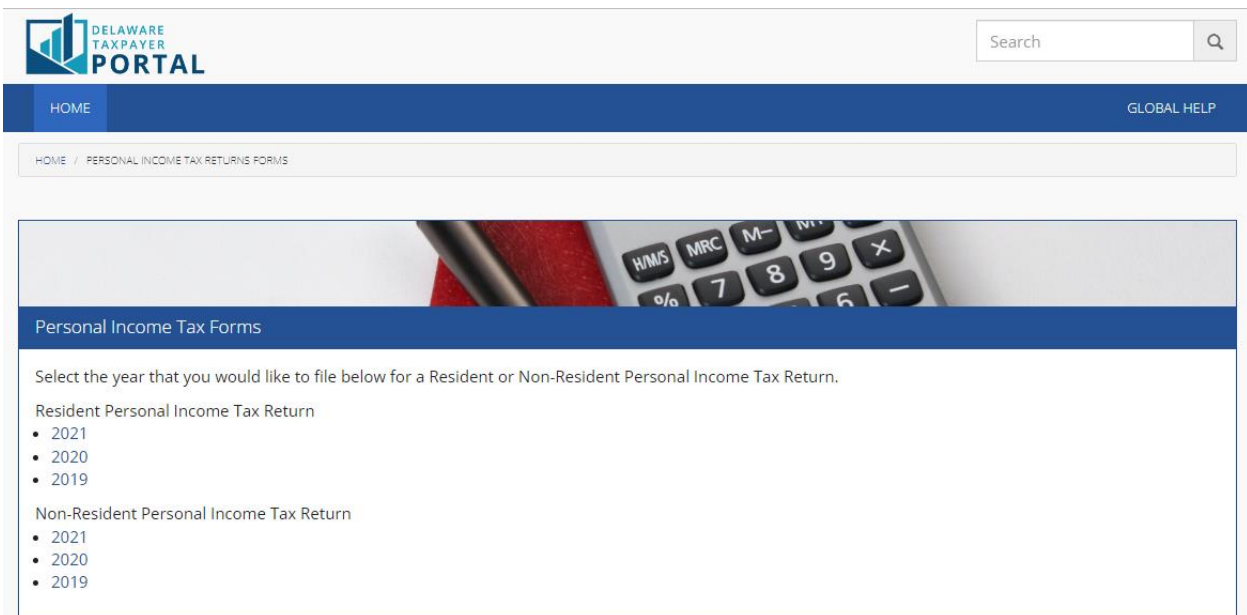
1 Select File a Return Link

Select the link to File a Personal Income Tax Return from the Individual section of the home page.



2 Select Tax Form

Select the year for the form you are filing.



3 Review and accept the Terms of Use

Delaware Personal Income Tax returns are presented online in a wizard format, provide the required information on each screen, selecting 'save and continue' to continue entering return information.

- Your return is saved each time you select 'save and continue.'
- Use the 'Delete' button if you wish to leave the filing wizard and delete any saved information.
- Use the 'Clear' button to clear information entered on the screen you are viewing.
- Use the 'Save and Exit' button to leave the filing wizard and receive your confirmation number to use to come back and complete the return later.




